In response to recent major fires, the New York City Fire Department released **two new videos** urging all New Yorkers to "Close the Door." Closing the door will prevent the spread of fire, smoke and heat. We'd like your help spreading this message to your community.

PROJECT: State Liquor Authority (SLA) License Renewals for the following Local Businesses:

The Quality Of Life (QOL) Committee reviews and provides comment on Liquor License Applications, Car Service Renewal Applications and other licenses for local businesses, restaurants, night clubs, and car service bases. Businesses come before the committee to present requested information and reply to <u>public comment</u>.

Candidates that apply to the **SLA** need a license to serve alcohol on premises. Under the NYS Alcoholic Beverage Control law, Community Boards are charged with reviewing these applications and providing recommendations to the SLA. The QOL Committee is the Public Hearing forum for you to weigh in on the Board's recommendations. Here are the list of SLA applicants that will be appearing before the committee on January 23rd - they will also be voted on at General Board Meeting on January 24th.

## SMART METERS ARE COMING TO EAST NEW YORK!

Con Edison's Smart Meters are coming! You may be asking yourself, "What's a smart meter?" Smart Meters are digital meters that communicate between your residence or business, and Con Edison through a secure wireless communication network. This means no more waiting for the meter to be read, no more estimates, and easier activation. From 2017 to 2022, Con Edison will be installing close to 5 million smart meters in Westchester and the 5 boroughs.

**Smart meters** do not collect, store, or transmit any personal information. Like a traditional **meter**, the only information collected is the amount of energy you use, and all your energy usage information is kept confidential by **Con Edison** and our vendors.

East New York maybe one of the first communities in

our Borough to receive the installations; which are reported to help with efficiency and provide real time monitoring of usage. Con Edison is required to provide advance notice of the transfer over to smart meters, so be on the look-out, and do your research to see what it entails for your home or business.

Customers can also opt out of the program if they are not interested in transferring over to smart meters by submitting the smart meter opt out application or by calling: (800) 576-2005

### **EXPAND YOUR SERVICES - APPLY FOR DISCRETIONARY FUNDS!**

The Fiscal Year 2019 (FY19) Discretionary Funding Expense and Capital Application Filing Period is open in NYC. If your organization has been looking for an opportunity to enhance your programming, or begin new initiatives - Discretionary funding may be exactly what you are looking for.

Local Not for Profit Organizations and other non-city organizations can apply to the NYC Council as well as the Borough President for Expense or Capital funding. These funding streams are a direct way to build capacity for your organization and to strengthen the services that you



provide to the district. (*Please note, in most cases the funding is reimbursed*).

The FY19 discretionary funding application is LIVE on the NYC Council website from January 2nd to February 20th. To apply, click the following link: FY19 Discretionary Funding Application

Non-City organizations applying for FY 2019 capital funding may now download and submit applications through the city's Cap Grant portal. To apply, click the following link: <a href="CapGrants portal">CapGrants portal</a>. Capital Grant deadlines vary.

## **Capital Projects Funded in Community Board 5**



In addition to expense funding that local non-profit organizations have received throughout CB5 to further support their services and programs; our NYC Council representatives, Council Members Barron and Espinal, have funded a number of capital projects in the district. Capital Grants provide funding for community infrastructure or installation of physical public improvement. This can include anything from renovating

parks to the installation of a school computer lab. These projects must have a value of \$35,000 or more and have a "useful life" of at least five years. Capital projects are funded through a number of ways in New York City, but here is a list of <u>just a few</u> projects that have been funded by the NYC Council representatives in CB5 in the previous fiscal year:

CM BARRON	New Lots Library: Additional Floor Constructed (3rd Floor)	Cost: \$2,078,000
CM ESPINAL	New School @ Dinsmore-Chestnut site: Construction of a Green House	Cost: \$833,000
CM BARRON	IS 364: Technology, STEM Lab, Sound Room Upgrades	Cost: \$210,000
CM ESPINAL	PS 151: Technology Upgrade / Computer Lab	Cost: \$500,000
CM BARRON	WATCH High School at Jeff Campus: Field Upgrades (Scoreboard & PA System), Weight Room, and Tech- nology	Cost: \$515,000
CM ESPINAL	NYCHA FIORENTINO HOUSES: Security Cameras Installed	Cost: \$777,000

Did you know that Community Boards can also apply for Capital Funding? Yes, Community Boards across the city can submit applications through the Borough President's office to request capital funding for projects in their districts.

- PROJECT DETAILS: Please provide exact location (Park, Roadway, School, etc.); whether the project is renovation, upgrade, new installation; cost of project (if known); and any details that you deem necessary.
- **VISION:** Provide a letter to the District Office with a minimum of 200 words on why you think this project should be funded in CB5
- PETITIONS/SUPPORT: Please provide supporting signatures from surrounding neighbors/businesses or letters of support.
