Community Board 5 Regular Monthly Meeting June 24, 2015

Chairman welcomed everyone to June meeting. He explained the meeting process to the new guest. He thanked the Genesis community for the use of their community facility. He asked recording secretary Rosalyn McIntosh, to started calling the public speakers.

Public Discussion

Nicole Usman, deputy director of safety from Department of Transportation spoke about Atlantic Avenue capital project vision zero great streets, part of Mayor de Blasio's great streets initiative. The project will be on Atlantic Ave between Georgia Ave and Conduit Blvd. The benefits of the proposal includes, raised, planted center median, left turn bays, left turn bans, midblock crossing, curb extensions and marking upgrades. The design will be completed by August 2016 and construction is scheduled to begin by spring 2017.

Zenovia Earle, Community Ambassador for Red Cross. She spoke about a disaster program in partnership with Governor Cuomo. She expressed that is a very basic program and it could be done online.
