COMMUNITY BOARD 5 REGULAR MEETING

Chair welcomed everyone to the May 27, 2015 meeting. He expressed his appreciation to the staff of Luis Pink Houses for allowing us to use the space. He then asked the Vice Chair to start announcing the public speakers; Recording Secretary Rosalyn McIntosh greeted everyone and started announcing the public speakers.

Public Speakers

BPL/ Brion from the Brooklyn Public Library announced that the New Lots library recently launched an Oral History Project. They will be having a Friends of New Lots meeting June 9th at 5:30PM, the meeting will be held at the New Lots Branch. He also mentioned the library was awarded \$20,000 recently.

Judge Genie Edwards, explained the functions of a civil court, she explained it has a jurisdiction of \$25,000. Anything from credit card debit to delinquent gas bills, issue with a friend or Contractor etc... it can be handle at civil court, she mentioned that there's a resource center there as well. She went on to say that civil court also handles housing issues. Landlord Tenant issues and small claims.

Charles Madray from the Good Samaritan Village announced that there will be a transfer of Oasis licensing to Samaritan Village, July 1, 2015. He announced that the services provided will remain the same. And mentioned that they will be adding adolescent services.

Mona Edwards from Out of School Youth sponsored by the Italian American League, program is based for participants from ages 17- 25 and who currently not enrolled in school. The program is a 4 week which includes a paid internship.

Edmund Chambers, Homeowner from the Shepherd Ave Association shared that he has been mentioning to the precincts that they need more cameras in their areas, along with stop signs and speed bumps. He went on to announce that there have been more than 3 murders in his area. He wants to get cameras on his block so they can protect their neighborhoods back.

COMMITTEE REPORTS:

Communication

Keron Allenye, asked everyone to check the website because their critique is most needed. He also mentioned the website will have a Board Member resource tab, Resource tab, by laws tab etc..; He encouraged any community or board member who wants to share any information that they may have thru the website email address. The chair thanked the Communication Committee for their hard work and dedication to the website. He also expressed that he is really excited about any inch of improvement the board makes. Thus the website along the Facebook page that will be forth coming this month.

Parks

Salema Davis, Parks Chair announced that the Parks Department gave a presentation on Sperandeo Brothers Park. The park is located at 350 Linwood St which is connecting to IS 302. There where renovations done in the past to this a park on the Atlantic Ave side and now the Parks Department would like to continue renovating on the Liberty Ave side. This project will consist of the handball courts and basketball courts. It will take the Parks Department at 9 months to complete this project; therefore the park will not be accessible. Project has not started. Council Member Rafael Espinal allocated funds for the completion of this project.

Social Services

Social Services committee Joyce Scoot-Brayboy. Stated last month Social Service committee met with CB16 social services committee regarding the shelter saturation throughout the community. She said they will be meeting with the Commissioner of the Department of Homeless services on June 16, 2015, at 6:00PM the topic of discussion will be "no more shelters in the communities".

Transportation

Transportation Chair, Wilfredo Florentine reported that the committee met on May 118th and all were invited. After a Statement the chair moved for a vote on the Bike Lane expansion in ENY Phase II. Christopher Banks motioned, second by Miguel Feliciano.

The Board voted, all in favor. 1Nay. The Letter of recommendation was approved.

District Manager Report:

Manager highlighted his report and informed all that a copy is in their folder. A copy is on file at the office.

Chairman Report:

Chairman welcomed all the new board members. He announced that for the first time ever they are now eligible to accept members as young as 16 years old. He said he wants to keep the door open for the young people to join. He would like to keep the young voices included. Talking with them instead of talking to them. He wanted to make it clear that being a Board member isn't just a title; you must be active and responsible on the Board. He said that he is really proud of the board members for taking time out to dedicate their time for the board because this is a volunteer work. He said he doesn't want anyone to come down on the board members because they are taking time out to help the community. He also said that the Board will have to stand firm on all the new changes that the community is about to face. He also announced that members can send their request for what committee they want to be in. He said he cannot guarantee everyone can get the slots that they request. He also mentioned that they Executive Committee met with the Department of City Planning, and notify them that their plans are not conducive to the community. He also mention that they will have a public presentation by the Department of City Planning sometime next month. He encouraged everyone to come out if he has any concerns and questions pertaining to the rezoning. He also spoke about the current shooting that take place a few minutes before the meeting started, and he said everyone duties in the community is to encourage everyone to stop the violence.

Old Business

Christopher Banks mentioned that a few months ago the board voted to suspend presentations on land use items and he wanted to know what principle and leg work has been put into place by the land use committee.

Chairman addressed Christopher Banks concerns by saying that they have had meetings with city official, elective officials, and also a tanning with the city comptroller office. He said that they did flush out and now they have a better understanding of the process without stopping the process. But they also want the developers to include the community in their planning.

Viola Plummer invited everyone to the June 22, Land Use Committee meeting and to feel free to bring and share any information or concerns he or she might have. She also mentioned they will have all the information the chairman had just mentioned.

Chairman announced that on Father's Day, Sunday June 21, 2015 Man up will be hosting a Walk against Violence. They will be starting on Ralph and Sutter Avenues ending on Lincoln and Sutter Avenues.
